## Call to Order and Pledge of Allegiance

Chairman Blair called the meeting of the Ohio Lottery Commission to order at 12:00 p.m.

#### Approval of Meeting Minutes

Chairman Blair moved to approve the One (1) new EZPLAY® Touch & Win/Tap Game Theme with Commissioner Gupta offering a second to the Motion. The Motion was affirmatively voted upon by the Commissioners present.

#### Resolution to Approve Video Lottery Terminal (VLT) Game Themes

Chief Legal Counsel LoPresti presented a Resolution to approve fifty-six (56) VLT game themes for inclusion in the video lottery game theme library. Chairman Blair moved to approve the Resolution, with Commissioner Mingo offering a second to the Motion. Commissioner Gupta abstained from voting and the Motion was approved by the remaining Commissioners present.

#### Office of Finance Report

Chief Fiscal Officer Ed Slyman provided the Commission with a financial update for the month of January. Total sales from traditional lottery games for the month were \$346.6 million, which was \$72.4 million, or 17.3 % less than sales generated last January.

Mr. Slyman noted that draw-based game sales for January were \$158.9 million, which was up \$44.7 million or 21.9% lower than the same month last year. Pick Games were up \$63.3 million, and Keno sales were \$9.6 million or down \$33.6 million from last January. Mega Million sales were \$9.6M or down by \$33.6M or 78% versus last January. Mr. Slyman stated that this is primarily due to the large jackpot offered last year.

Mr. Slyman reported that Scratch-Off game sales for the month were \$187.6 million, approximately \$27.8 million lower than last year. Mr. Slyman reported that Gross Gaming Revenue from VLTs equaled \$100.9 million, which was \$9.8 million more than less than last year.

Lastly, Mr. Slyman reported that total prize expenses for January were around \$240.0 million, or 69.2% of sales. Draw-based expenses were &96.5 million, or 60.7% of draw-based game sales. Prize expenses for scratch-off tickets equaled. Operating expenses were \$14.3 M for the month, which was slightly less than what was forecasted.

# Director's Report

Director Gillcrist reported that the Lottery's transfer to the Lottery Profits Education Fund (LPEF) for the month of January was \$119.5 million. Director Gillcrist noted that this was slightly down than the Lottery's budgeted commitment for the month, but fiscal year-to-date total profits are approximately \$42.0 million higher than our budgeted commitment. Additionally, Director Gillcrist provided the Commissioners with a copy of the latest Annual Comprehensive Financial Report and thanked staff for all their hard work in preparing the document.

Director Gillcrist introduced Marilyn Berrios as her new assistant in the Executive Office. Meg Rassmussen, Office of Legal and Terri Jones, Office of Marketing were thanked for their assistance over the past several months.

Director Gillerist announced that the 21<sup>st</sup> Annual Ohio Problem Gambling conference would occur on February 15<sup>th</sup> & 16<sup>th</sup> in Columbus. Director Gillerist introduced Responsible Gambling Deputy Director Jimmie Hicks to provide an overview of the upcoming conference. Deputy Director Hicks noted that this is a collaborative effort with the Ohio for Responsible Gambling consortium and the Problem Gambling Network of Ohio. Mr. Hicks also thanked Susan Diamond for her assistance in planning the conference.

# **Retirement Recognition**

Chairman Blair acknowledged the retirements of two Lottery employees from the Sales Department, Tina Garcia and Darek Whitmore. The Chairman then asked Rick Perk, Deputy Director of Sales, to say a few words to acknowledge each employees Lottery careers.
