# APPROVAL OF MINUTES OF MAY 11, 2022

Chairman Blair presented to the Commission for approval the minutes from the May 11, 2022, meeting. Commissioner Mingo made a Motion to Approve the minutes, seconded by Commissioner Sweeney. The Motion was affirmatively voted upon by the seven Commissioners present.

Chairman Blair moved to approve the fifteen (15) Administrative Rules in Proposed Form. With Commissioner Mingo offering a second to the motion. The Motion was affirmatively voted upon by the Commissioners present.

# RESOLUTION TO APPROVE VIDEO LOTTERY GAME THEMES

Mr. Carter presented a Resolution to approve 35 Video Lottery Game Themes.

Chairman Blair moved to approve the Resolution, with Commissioner Sweeney offering a second to the Motion. The Motion was affirmatively voted upon by the Commissioners present.

#### FINANCIAL REPORT

Office of Finance Deputy Director Greg Bowers provided to the Commissioners a financial update for the month of May 2022.

Sales from Traditional Lottery games for the month of May were \$350.9 million, which is a 9.1 % decrease (or \$35M) from the record set in May 2021.

Scratch-off game sales fell 9.4%, however other lotteries are experiencing the same downward trend.

Draw-based game sales fell 8.7% despite an increase in sales from Classic Lotto which was up 18.6% over last year due to higher jackpot levels.

Sales from the Multi-State jackpot games were lower than last year as both jackpot games had an advertised jackpot less than last year.

VLT revenue was \$114.9 million. The net profit from that equaled \$37.7 million, which was \$2.2 million less than last year

Total prize expense equaled 66.1% of sales.

## DIRECTOR REMARKS

The Director informed the Commission that the Lottery requested OBM to transfer \$118 million to the Lottery Profits Education Fund (LPEF), which is \$18.3 million above our commitment. Upon posting of this transfer, year-to-date through May, Lottery profits will \$47.8 million ahead of last year. It is forecasted that we will end this fiscal year ahead of last year's transfer, despite lower profit transfers over the past few months.

As of Saturday, June 4<sup>th</sup>, traditional sales officially exceeded \$4 billion. From my days on the commission, we were always striving to reach the 4-billion-dollar mark.

On May 23<sup>rd</sup>, the Lottery launched expanded prize cashing services at our regional offices and racino locations. These locations can now pay prizes up to \$25,000, the prior limit was \$5,000. These thresholds mirror the limit for mobile cashing and is an added convenience to our players. Prior to this implementation, any prize over \$5,000 would have to be mailed in and go through the state accounting process.

Director McDonald gave an update on Sorts Gaming. The Lottery continues to push forward and make great progress with both the Hosts and Proprietors. The Lottery posted the initial batch of pre-qualified hosts to our website on Friday, June 3rd. The Lottery will continue to update this list each week as we approach the Ohio Casino Control Commission application window opening in July. In the meantime, the Lottery will be assisting Proprietors with their proposal submissions for Lottery review. With the application window opening next week, we are having conversations regarding the requirements of the process. Jon Dillinger, Director of Sports Gaming provided more detail on the application process.

Director McDonald informed the Commissioners about the Lottery strategic planning session that took place in person with our senior and regional management teams since the beginning of the pandemic. The purpose of this meeting was to identify on-going issues, concerns, and areas of opportunity as well as discuss potential actionable solutions over the next three years within our industry. Topics included building the budget based on the strategic plan and promoting diversity, equity, and inclusion initiatives. This allowed for a productive and educational conversation that helped connect our teams across the state. We plan to continue these meetings on a more frequent basis, potentially quarterly, going forward.

Director McDonald reported that the Senate voted 30-2 to pass SB 269 which would authorize iLottery. After several years of waiting, we are excited to finally see this bill be passed and are hopeful it will make it through the House with haste. Nick Ciofani, Director of Government Affairs, provided more details.

The Lottery Audit Committee held their quarterly meeting earlier today. The agenda item of note was the review and approval of our governance documents and audit plan for FY2023. Our Audit Committee Chair, Commissioner Mingo will be providing a full report at our July meeting.

## **ADJOURNMENT**

With no further business before the Ohio Lottery Commission, Commissioner Brady informed Commissioners that the next meeting will be held on Wednesday, July 13, 2022, at 12:00 p.m. via teleconferencing and in person by invitation.
