### Call to Order and Pledge of Allegiance

Chairman Matthew Blair called the meeting of the Ohjo Lottery Commission to order at 12:00 p.m.

# Approval of Meeting Minutes

Commissioner Sweeney moved to approve the March 12, 2025, meeting minutes. The motion was seconded by Commissioner Gupta and was affirmatively voted upon by the Commissioners present.

### Audit Committee Update

Audit Committee Member, Commissioner Sweeney, provided an update on the March Audit Committee meeting on behalf of Audit Committee Chair Mingo. Commissioner Sweeney reported that during the March Meeting the Audit Committee discussed the new Global Internal Audit Standards, that went into effect in January. The Audit Committee also discussed the results of two audit projects that were completed. The first project was the Payment Card Program audit, which had two objectives. First, to ensure that the Lottery adheres to both internal and external purchasing policies and procedures, and second, that the Lottery adheres to the Minority Business Enterprise (MBE) purchasing requirements. Commissioner Sweeney reported that both objectives were well controlled, and no material issues were noted. The second project was the Responsible Gambling Messaging audit, which had two objectives. First, to

evaluate the design and effectiveness of controls over the Responsible Gambling messaging processes, and second, to evaluate the design and effectiveness of controls to ensure retailer compliance with responsible gambling messaging. Both objectives were noted as improvements needed, and no material issues were noted during the audit

In addition, Commissioner Sweeney informed the Commission that the Internal Audit team started their annual risk assessment process and as part of the process the Commissioners would receive an email with a link to a survey that has three questions. The Commissioners' input will assist the Internal Audit team.

Chairman Blair moved to approve nine (9) Administrative Rules in Proposed Form, with Commissioner Candisky offering a second to the Motion. The Motion was affirmatively voted upon by the Commissioners present.

Chairman Blair moved to approve eight (8) Administrative Rules in Final Form, with Commissioner Mingo offering a second to the Motion. The Motion was affirmatively voted upon by the Commissioners present.

# Resolution to Approve twenty-two (22) new Video Lottery Terminal (VLT) Game Themes

Daniel Carter, Acting Chief Legal Counsel, presented a Resolution to approve twenty-two (22) VLT game themes.

Chairman Blair moved to approve the Resolution with twenty-two (22) VLT game themes with Commissioner Gupta offering a second to the Motion and the Motion was approved by all Commissioners present.

### Office of Finance Report

Chief Fiscal Officer Ed Slyman provided the financial update for the month of March. The total traditional lottery games sales for the month of March were \$392.5 million, which is \$32.8 million or 7.7% less than the sales generated last year. Draw-based game sales were \$173.7 million, which was \$34.7 million or 16.6% lower than the same month last year. Pick 3, 4, and 5 sales were \$66.9 million, up approximately \$2.2 million or 3.4%; March represents the first positive variance this FY for this category. Multistate game sales were \$25 million, down \$37.3 million or 59.8% lower when compared to the same time period last year. Mr. Slyman stated that this large variance can be attributable to the higher jackpots offered last year. For example, Mega Millions reached \$1.1 billion before it was won on March 26, 2024. In addition, Powerball reached \$951 million by the end of March. Mr. Slyman informed the Commission that if the sales for these highly unpredictable games were removed, total traditional sales would be up \$4.4 million or 1.2%.

Keno sales were \$55.9 million, down \$1.1 million or 1.8%. Mr. Slyman stated that March 1, 2024, was a Friday, and Fridays are typically the best performing day of the week for Keno. March 1<sup>st</sup>, of this year, started on a Saturday. EZ Play sales were \$10.4 million, up \$2.4 million or 29.5%. This was mainly attributable to the higher Progressive jackpots offered. (Ohio Jackpot 7's - \$1.0 million won in Dayton).

Scratch-off ticket sales in March were \$218.8 million, down \$1.8 million or 0.8% higher than last year. Mr. Slyman informed the Commission that this was the 8<sup>th</sup> highest selling month in the Lottery's history and the 2<sup>nd</sup> highest sales for the month of March. The \$10 games lead all price point sales at \$50.5 million, accounting for 23.1% of sales. The \$20 games were second with sales of \$47.5 million, accounting for 21.7% of total sales, and the \$5 games led the way with the most tickets sold of over 7 million. Self-service sales for the month were \$59.4 million. An increase compared to last year of \$831k or 1.4%.

Mr. Slyman reported that the VLT gross revenue was \$133.0 million in the month of March, which represents a new record for the all-time highest monthly revenue. The previous record was March of 2024, at \$128.7 million. This represents an increase of \$4.3 million or 3.3% when compared to last year. Year-to-date, VLT gross revenue is up \$15.9 million, or 1.6% compared to the first nine months of last year.

Lastly, CFO Slyman reported that the total prize expense for March was \$259.2 million, or 66.1% of sales, and operating expenses were as expected.

# Director's Update

Director Michelle Gillcrist reported that the Lottery's transfer to the Lottery Profit's Education Fund (LPEF) for the month of March was approximately \$136.1 million. This is \$6.5 million more than the Lottery's commitment, still \$14.6 million lower than last March. Director Gillcrist stated that the Lottery has transferred approximately \$1.12 billion to the LPEF, which is roughly \$13.3 million ahead of our Fiscal Year-to-date commitment.

Director Gillcrist informed the Commissioners that there were resolutions circulating for three retiring employees. James Torain served as a Lottery Sales rep, Andy Rokakis served as an Electronic Design Specialist, and John Parks served as a Lottery Sales Rep. Director Gillcrist thanked each of them for their many years of service and dedication to the Lottery's mission.

Director Gillerist shared that the Partners in Education Program (PIE) was selected as the recipient of the 2025 Ohio Education Association (OEA) Friend of Education Award. Director Gillerist stated that this recognition is a testament to the hard work and dedication of the team, particularly the Partners in Education Program Coordinator, Molly Fanta.

Director Gillcrist invited Cash Explosion's Executive Producer, Barry Riley, to provide some details regarding the Cash Explosion Road show that will take place in Youngstown in the month of June.

Lastly, Director Gillcrist invited the Lottery's Deputy Director of Marketing, Tom Ackerman, to present on the "Know the Odds" campaign, which helps educate the public on Lottery games.
