Call to Order and Pledge of Allegiance

Chairman Blair called the meeting of the Ohio Lottery Commission to order at 12:03 p.m.

Approval of Meeting Minutes

Chairman Blair requested approval of the minutes from the March 13, 2024, Commission meeting. Commissioner Szollosi made a motion that was seconded by Commissioner Mingo and was affirmatively voted upon by the Commissioners present.

Audit Committee Update

Audit Committee Chair Mingo provided an update on the March Audit Committee meeting. Commissioner Mingo stated that the status of the current year's audit plan had been reviewed. There were six projects completed with five additional projects currently underway. Commissioner Mingo also informed the Commission on a recent consulting engagement on the Lottery's fleet vehicle management and reminded the Commissioners to participate in the annual risk assessment.

Chairman Blair moved to approve the nineteen (19) Administrative Rules in Final Form with Commissioner Brady offering a second to the Motion. The Motion was affirmatively voted upon by the Commissioners present.

Resolution to approve two (2) new EZPLAY® Touch & Win and Tap Game Themes

Charles LoPresti, Chief Legal Counsel, presented a resolution to approve two (2) new EZPLAY® Touch & Win and Tap Game Themes:

- Three Roll Jackpot
- Summer Fortune

Chairman Blair moved to approve the Resolution, with Commissioner Sweeney offering a second to the Motion. The Motion was approved by the remaining Commissioners present.

Resolution to Approve twenty- three (23) new Video Lottery Terminal (VLT) Game Themes

Charles LoPresti, Chief Legal Counsel, presented a Resolution to approve twenty-three (23) VLT game themes.

Commissioner Brady objected to one of the game themes named "Big Juan" as he was concerned it appeared offensive. Discussion ensued and Chairman Blair made a motion to amend the Resolution found on agenda item 12 to remove the "Big Juan" theme from the Resolution. Commissioner Brady seconded to the Motion and the Motion was affirmatively voted on.

Chairman Blair then moved to approve the amended Resolution with twenty-two (22) VLT game themes. Commissioner Sweeney seconded to the Motion and the Motion was approved by all Commissioners present.

Office of Finance Report

Chief Fiscal Officer Slyman provided the financial update for the month of March. Mr. Slyman stated that total sales from traditional lottery games for the month were \$424.7 million, which was \$28.4 million or 7.2% more than sales generated last year. Draw-based game sales for March were \$207.7 million, which was \$31.8 million or 18.1% higher than the same month last year.

Mr. Slyman reported that daily draw game sales were \$64.7 million, down \$3.3 million or -4.9% versus last year. Additionally, Mr. Slyman stated that multi-state games, such as Powerball, Mega Millions, and Lucky for Life generated sales of \$62.3 million, an increase of \$40.3 million, or 183.3% vs last year. Mr. Slyman attributed the gains to the fact that Mega Millions reached \$1.13 billion in March and Powerball ended the month with an advertised jackpot of \$950 million. CFO Slyman stated that Keno sales were \$56.3 million, down \$2.9 million or 5% compared to last year. Scratch-Off game sales for the month of March were \$217 million, \$3.3 million or 1.5% lower than last year.

Turning to the racino revenues, Mr. Slyman reported that Gross Gaming Revenue from VLTs equaled \$128.7 million, which was \$3.5 million, or 0.7% million less than last March. Mr. Slyman noted that this March's performance was an all-time record for VLTs.

Lastly, Mr. Slyman reported that total prize expense for March was \$271.3 million, or 63.9% of sales, which is lower than normal. Year-to-date, traditional lottery sales are \$3.45 billion, up \$45.6 million when compared to the first

nine months of last year. Discussion ensued regarding the challenges of certain product lines, like Keno, due to the legalized competition of sports gaming. Chairman Blair commended the staff for continuing to meet these challenges and noted the importance of the Lottery's contribution to education.

Director's Report

Director Gillcrist reminded the Commission that the Lottery is a member of the Legislative Committee to study the future of gaming in Ohio. Ms. Gillcrist stated that each of the four scheduled meetings have ended. Throughout each session, several interested parties from the Casino, Sports Betting, Lottery, Retail, iGaming, iLottery, Charitable Gaming, Problem Gambling, Veterans and Horse Racing industries. The Committee is now tasked with issuing some type of recommendation or report and will sunset June 30th.

Director Gillcrist informed the Commission that she attended the Governor's "State of the State" address where he focused a lot of his attention on children's literacy and education initiatives. Director Gillcrist informed the Commission about the last Cabinet meeting where she had the opportunity to bring someone from the agency who is focusing on education initiatives at the agency level. The Director brought Molly Fanta, who is a former teacher and the Lottery's Partner's in Education coordinator. Ms. Fanta works to promote the Governor's literacy program in addition to her day-to-day work.

Director Gillcrist stated that the Lottery's transfer to the Lottery Profits Education Fund (LPEF) for the month of March was \$150.6 million, \$25.3 million more than last year, an all-time record. YTD transfers to the LPEF are \$1.17 billion, which is \$69.4 million ahead of our commitment and \$32.8 million over last year.

Lastly, Director Gillerist invited Deputy Director of Communications, Danielle Frizzi-Babb, to show a recap video of how our Partner's in Education "School of the Year" from last year went. This video highlighted how Revere Middle School utilized their prize to help grow their "Revere Roasters" class program that teaches its students how to manage a business and provide excellent customer service.

ADJOURNMENT

With no further business before the Ohio Lottery Commission, Chairman Blair informed Commissioners that the next meeting will be held on Wednesday, May 8, 2024, at 12:00 p.m. via teleconferencing and in person. Chairman Blair adjourned the April 17, 2024, meeting at approximately 12:47 p.m.
