# Call to Order and Pledge of Allegiance

Chairman Matthew Blair called the meeting of the Ohio Lottery Commission to order at 12:04 p.m.

### Approval of Meeting Minutes

Commissioner Szollosi moved to approve the February 12, 2025, meeting minutes. The motion was seconded by Commissioner Sweeney and was affirmatively voted upon by the Commissioners present.

# Resolution to Approve two (2) new EZPLAY® Games

Daniel Carter, Acting Chief Legal Counsel, presented a Resolution to approve two (2) new EZPLAY® Games

- \$10 OH Keno (April EZPLAY® Game)
- \$200 Karat (April EZPLAY® Game)

Chairman Blair moved to approve the Resolution with two (2) new EZPLAY® Games with Commissioner Gupta offering a second to the Motion and the Motion was approved by all Commissioners present.

# Resolution to Approve fifty (50) new Video Lottery Terminal (VLT) Game Themes

Daniel Carter, Acting Chief Legal Counsel, presented a Resolution to approve fifty (50) VLT game themes.

Chairman Blair moved to approve the Resolution with fifty (50) VLT game themes with Commissioner Sweeney offering a second to the Motion and the Motion was approved by all Commissioners present.

## Office of Finance Report

Chief Fiscal Officer Ed Slyman provided the financial update for the month of February. The total traditional lottery games sales for the month of February were \$335.3 million, which is \$25.4 million or 7% less than the sales generated last year. Mr. Slyman noted that last February had one additional day that generated approximately \$12.5 million in sales. Draw-based game sales were \$148.3 million, which was \$13.3 million or 8.2% lower than last year. Collectively, Pick 3, 4, and 5 sales were \$57.9 million, down \$3.4 million or 5.5%. Multistate sales were \$18.5 million, down \$7.4 million or 28.7% lower when compared to last February. Mr. Slyman stated that last February both Mega Millions and Powerball had higher jackpots on average when compared to this current period.

Keno sales were \$52.0 million, up \$1.1 million or 2.3%. Scratch-off games sales in February were \$187.0 million, down \$12.1 million or 6.1% lower than last year. The extra day last year, February 29<sup>th</sup>, generated sales of over \$7.7 million. Mr. Slyman shared that for the first time, the \$50 product line led all the price points with \$41.6 million in sales. This price point accounts for roughly 22.3% of sales. The \$10 price point games followed with \$41 million in sales and accounted for 21.9% of sales. The \$5 games led the way with the most tickets sold, 6.2 million.

Mr. Slyman reported that the VLT revenue for the month of February was \$108.7 million. Of this, \$71.9 million was distributed to the Racinos as commission earned and \$36.4 million represented revenue for the Ohio Lottery. The net win for the extra day in February of last year was \$4.5 million, which translates to \$1.5 million for the Lottery. Mr. Slyman noted that Belterra Park was closed from 11:00am on February 18, 2025, to 5:00pm on February 20, 2025, due to the river flooding.

Lastly, CFO Slyman reported that the total prize expense equaled 68.1% of sales. The Lottery had higher than expected prize expenses for both Pick 4 and Keno. Pick 4 was 72.5% while Keno was 73%. Operating Expenses were lower than forecasted.

#### Director's Update

Assistant Director Nicole Kostura provided the update on behalf of Director Michelle Gillcrist. Assistant Director Kostura reported that the Lottery's transfer to the Lottery Profit's Education Fund (LPEF) for the month of February was approximately \$110.8 million. This is \$3.8 million lower than last February. Assistant Director Kostura noted that last February there was an extra day in the month and there were other things to compete with. Fiscal year-to-date the Lottery has transferred approximately \$987.7 million to the LPEF, which is approximately \$6.8 million ahead of its fiscal year-to-date commitment.

Assistant Director Kostura reminded the Commission that the multi-state game Mega Millions will be transitioning to a \$5 price point. The new game will feature bigger prizes at every level, an included multiplier, and bigger jackpots. Assistant Director Kostura stated that the Lottery's team have been diligently working to help distribute new material and get retailers ready for this transition, which will happen on April 4<sup>th</sup>. Deputy Director Morrow gave a presentation on Mega Millions.

In the month of April, the Lottery will be hosting the North American Association of State & Provincial Lotteries (NASPL) Annual Leadership Institute Conference in Cleveland from April 14<sup>th</sup> to April 17<sup>th</sup>. There will be approximately 100-120 Lottery professionals from across North America to learn about the Lottery industry, how to grow their careers, and NASPL puts them thorough a leadership academy as well. The Lottery will provide presentations on various Sales, Marketing, and regulatory efforts. The Director will participate with the Illinois

Director on an industry panel with David Gale. Assistant Director Kostura extended an invitation to the Commissioners to attend the Conference.

Lastly, Assistant Director Kostura informed the Commission that the Deputy Director of Responsible Gambling, Jimmie Hicks, was asked to join a panel at the NASPL conference with the Department of Mental Health and Addiction Services (OHMAS), and with the Problem Gambling Network of Ohio, as Ohio is known as the "Ohio Model" when it comes to Responsible Gambling. Assistant Director Kostura invited Deputy Director, Jimmie Hicks, to give a brief update as to what is going on across the state as March is Problem Gambling Awareness Month.
