#### Call to Order and Pledge of Allegiance

Chairman Blair called the meeting of the Ohio Lottery Commission to order at 12:00 p.m. The meeting was held in-person and via teleconferencing.

## Approval of Meeting Minutes

Chairman Blair requested approval of the minutes from the August 9, 2023, Commission meeting. Chairman Blair made a motion to approve the minutes, seconded by Commissioner Brady. The motion was affirmatively voted upon by the Commissioners present.

#### Approval of Three (3) Scratch-Off Games in Proposed And Final Form

Chairman Blair moved to approve the three (3) scratch-off games, with Commissioner Gupta offering a second to the Motion. The Motion was affirmatively voted upon by the Commissioners present.

Chairman Blair moved to approve the five (5) scratch-off games, with Commissioner Sweeney offering a second to the Motion. The Motion was affirmatively voted upon by the Commissioners present.

Chairman Blair moved to approve the four (4) scratch-off games, with Commissioner Brady offering a second to the Motion. The Motion was affirmatively voted upon by the Commissioners present.

# Resolution to Approve Video Lottery Terminal Game Themes

Acting Chief Legal Counsel Dan Carter presented a Resolution to approve thirty-nine (39) Video Lottery Terminal (VLT) game themes for inclusion in the video lottery game theme library. Chairman Blair moved to approve the Resolution, with Commissioner Brady offering a second to the Motion. Commissioners Brady, Blair, Candisky, Hughes, Mingo, Rickel, and Sweeney approved, and Commissioner Gupta abstained. Therefore, the motion was approved.

Mr. Carter also presented again the resolution to approve eighteen (18) Video Lottery Terminal (VLT) game themes for inclusion in the video lottery game library that were presented at the August Commission meeting but did not pass. Chairman Blair moved to approve the Resolution, with Commissioner Mingo offering a second to the Motion. Commissioners Blair, Brady, Candisky, Hughes, Mingo, Rickel, and Sweeney approved, and Commissioner Gupta abstained. Therefore, the motion was approved.

#### Financial Report

Chief Fiscal Officer Ed Slyman provided the Commission with a financial update for the month of August. Total sales from traditional lottery games for the month were \$386.3 million, which was \$41.7 million, or 12% higher increase over last August. Mr. Slyman stated that the majority of the variance came from higher profit games such as Mega Millions and Powerball, along with the Pick family of games and Scratch-Off Games.

Mr. Slyman reported that Scratch-Off game sales for the month were \$190.5 million, or 4.6.% higher than last year, and sales from Mega Millions were \$38.3 million, up \$29.5 million, or 335% higher than last year. Powerball sales were \$13.7 million or \$5.6 million up vs last Fiscal Year or 68% higher. Pick Games were up \$4.7 million or 7.6% as well. Mr. Slyman also reported that Keno, EZ Play, Touch & Win, and Tap games were all down for the month compared to last fiscal year.

Turning to the Racinos, Mr. Slyman informed the Commission that Gross Gaming Revenue (GGR) from VLTs for the month was \$112.5 million, which was \$0.8 million more than last year. Lastly, Mr. Slyman reported the prize expense represented 64.9% of traditional sales, which is higher than normal expected payout.

# **Executive Director's Report**

Chairman Blair asked Director Michelle Gillcrist to give the Director's report. Director Gillcrist welcomed the Commissioners and reported on the Lottery's transfer to the Lottery Profits Education Fund (LPEF) for the month of August. The LPEF transfer was \$126.2 million, which was \$6.7 million more than budgeted commitment for the month and \$15.9 million more than last August. Year-to-Date through August, Lottery profits were \$13.9 million higher than our commitment and \$10.3 million ahead of last year.

Director Gillcrist informed the Commissioners announced some organizational changes. She congratulated Marty Morrow as the new Deputy Director of Product Innovation and Mike Gonzalez as the agency's Chief Data Officer.

Director Gillcrist invited Deputy Director of Communications, Danielle Frizzi-Babb to recap the recent Partners in Education "School of The Year" celebration that took place on Friday September 15, 2023, at Revere Middle School. Additionally, Deputy Director of Marketing, Tom Ackerman gave an update on some of the changes made to the Lottery's Partners in Education program for the coming year.

Director Gillcrist thanked Commissioners Blair, Gupta, and Mingo for joining the recent Cash Explosion Road Show, which was a great success. Ms. Gillcrist then invited the Deputy Director of Responsible Gambling, Jimmie Hicks, to give an overview of the Responsible Gambling department's work, as September is Responsible Gambling Education Month.

Director Gillcrist then introduced Sports Gaming Operations Manager, Jon Dillinger, who provided an update on the Lottery Sports Gaming department.

Lastly, Director Gillcrest congratulated Commissioners Brady, Mingo and Candisky on their reappointment. Director Gillcrist announced the October Commission meeting will take place at Lottery

central headquarters and November Commission meeting will take place at the Hollywood Gaming at Mahoning Valley Racino.

With no further business before the Ohio Lottery Commission, Chairman Blair informed Commissioners that the next meeting will be held on Wednesday, October 11, 2023 at 12:00 p.m. via teleconferencing and in person and adjourned the meeting.
