CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Vice Chairman Blair called the meeting of the Ohio Lottery Commission to order at 12:00 p.m. The meeting was held in person and via teleconferencing.

RESOLUTION TO APPROVE VIDEO LOTTERY GAME THEMES

Mr. LoPresti presented a Resolution to approve 41 Video Lottery Game Themes for inclusion in the video lottery game theme library.

Chairman Blair moved to approve the Resolution, with Commissioner Hughes offering a second to the Motion. The Motion was affirmatively voted upon by the Commissioners present.

FINANCIAL REPORT

Office of Finance Deputy Director Greg Bowers provided to the Commissioners a financial update for the month of August 2022.

Sales from traditional lottery games for month of August were \$344.2 million, which was a 1.4% decrease from sales generated last fiscal year.

Sales from scratch-off tickets were \$182.0 million, down slightly from last year by only 1.0% or \$1.9 million. Draw-based game sales were down 1.9% or \$3.1 million from last year in August.

Multi-state jackpot games Mega Millions and Powerball were down by 13.5%, as jackpot levels advertised were lower this year vs last year. The highest jackpot for Mega Millions was \$153 million vs \$306 last August, while for Powerball the high was \$134 million vs \$332 M last August.

Sales derived from the daily draw games Pick 3, Pick 4, and Pick 5 also fell against last year, down 8.0% or \$5.4 million.

Gross Gaming Revenue from VLTs for the month was \$111.7 million, down 1/10th of 1% (0.13%). Net profit from that equaled \$36.6 million, which was just \$55,000 less than last year.

The Accounting department is wrapping up the annual audit with the Auditor of State and is still putting together the annual comprehensive financial report (ACFR). They have completed draft Financial Statements, the Management Discussion & Analysis, Notes to the Financial Statement, and Stats. The lottery is to send all components to the AOS for their review next week and plans to receive the opinion letter dated on September 30th.

The Lottery is working towards developing the next budget for the fiscal year 2024-2025 Biennium. The focus for the next several weeks is to work with Sales/Marketing, along with data analytics, to begin drafting sales forecasts.

Finance is also heavily involved in incorporating sports gaming into our financial reporting model and assisting with the launch on Jan 1st.

DIRECTOR REMARKS

The Director informed the Commission that the LPEF transfer for the month of August 2022 was \$110 million which is our second highest August to date and \$3.3 million less than August of 2021. For the first two months of the fiscal year, we are \$11.2 million ahead of last year. This is largely due to the \$1.3-billion-dollar jackpot in July.

The Director introduced the newest member of the Lottery senior staff Jimmie Hicks, who will be replacing Karen Russo as Deputy Director of Responsible Gambling. Deputy Director Hicks introduced himself and gave a brief overview of his professional background.

Director McDonald informed the commission that as of last week, the Ohio Lottery has recommended 1,368 host locations to the Ohio Casino Control Commission. They have received 827 host applications and have approved 500. We are currently working with 7 vendors that will be offering sports betting to the retailers pending issuance of Proprietor licenses by the OCCC.

Sports Gaming Operations Manager Jon Dillinger gave an update his department's work and progress to implement lottery sports gaming. He provided an update on the lottery sports gaming rules as they work through the rulemaking process, highlighted his department's continued work on operating standards for the proprietors, and answered questions on how the different proprietors are proposing to set-up their equipment and systems in host locations.

Deputy Director of Marketing Sandy Lesko Sabbath and Marketing Assistant Director Tom Ackerman gave a presentation on the upcoming holiday season ticket support and advertising campaign strategies.

Director McDonald spoke about First Lady Fran DeWine work to expand the Dolly Parton's Imagination Library throughout Ohio. Director McDonald provided an overview of the program and informed the Commission that the Lottery will be highlighting the importance of the program on the Cash Explosion Show. Both Director McDonald and Chairman Blair expressed the importance in promoting this program.

Director McDonald gave an update on the Combined Charitable Campaign. The Lottery has donated over \$28,600 to the campaign, The Lottery would like to exceed its goal of \$47,000. The Director urged those who have not donated at this time to please consider contributing. Participation is important.

Chairman Blair introduced Ray Durant, Director of Security at the Lottery. Director Durant's son Tyson was recently awarded a 4-year scholarship for football by the University of Akron Zips.

EXECUTIVE SESSION

Chairman Blair made a motion that the commission would go into executive session for the purpose of discussing the investigation and discipline of certain public employees pursuant to Ohio Revised Code 121.22 and Ohio Revised Code 149.43. the motion was seconded by Commissioner Sweeney.
